# Purpose of the Meeting.

The purpose of the meeting was to discussing scoring of applicants submitted by committee members for consideration for interviews, and to decide whether interviews are necessary to determine which applicants would be forwarded for consideration by the Governor and Cabinet.

# Discussion.

State Attorney Phil Archer made a statement about the signed letter in support, on behalf of the Florida Prosecuting Attorneys Association, for Richard Davison. He didn't make any personal recommendations and will remain fair and impartial.

### Approval of October 8, 2020, minutes.

State Attorney Phil Archer moved to approve the minutes of the October 8, 2020, Committee meeting. Sheriff Ashley and Sheriff Ford seconded the motion. The vote was unanimous.

#### Selection of candidates

State Attorney Phil Archer moved to submit the final top three (3) scoring candidates, and not conduct interviews. Sheriff Ashley seconded the motion. The vote was unanimous.

The following candidates were selected:

- (1) Richard Davison;
- (2) Susan Whitworth; and
- (3) Cynthia Swier.

Scoring of candidates for selection of interviews

The Committee members scored each candidate whose names was submitted for consideration for an interview. Each committee member drafted a list ranking up to ten (10) applicants. The applicants were ranked from 1-10, with 1 being the highest rank. Each rank has a designated point score, and a score of 0 may be given by a committee member for any applicant not ranked on his list. The candidates were scored as follows:
