Division of Operations

The Division of Operations is the largest unit of the Commission and is comprised of four sections: the Revocations Unit, Victims' Services, Office of the Commission Clerk, and Field Services. Twelve field offices are divided among five regional areas across the state with each region staffed by an Administrator who directs the day-to-day activities of the professionals and support staff assigned to offices located within the region.

Operations is responsible for multiple functions in the administration of post-prison supervisory release programs. These supervised release programs include parole, conditional medical release, control release, conditional release, and addiction recovery release supervision. Through its Field Services staff, Operations conducts parole interviews, administrative hearings for alleged violations of supervision, as well as clemency investigations for the Board of Executive Clemency.

Division of Administration

Office of General Counsel

The Office of the General Counsel is charged with successfully prevailing on litigation filed against the Commission; providing quality legal advice and representation in a prompt manner; and engaging in proactive legal counseling to prevent unnecessary litigation in the future.

Accomplishments: December 2018

During the month of December, the Office of the General Counsel generated forty-five (45) court filings, including briefs, responses, motions, orders, and notices. The Office of the General Counsel responded, through completion, to forty-five (45) public records requests.

Monthly Accomplishments Report

During the month of December, the Commission received thirteen (13) positive orders, from state circuit courts, district courts of appeal, and federal courts, including the Eleventh Circuit Court of Appeals. These orders are in the nature of reaffirming long-held and long-standing precedent governing some of the more common challenges presented against the Commission, including the denial of a grant of credit for time out on supervision after a supervision revocation, the recommendation for particular programming, the placement of an offender on conditional release, the Commission's discretionary authority to impose special conditions in a conditional release order, the Commission's denial of a grant for a special interview, the sufficiency of the evidence presented at revocation hearings, and the Commission's decision to aggravate for unsatisfactory institutional conduct and its decision not to mitigate based on particular information set forth by an inmate.

Office of Legislative Affairs

The Office of Legislative Affairs is charged with overseeing the Commission's legislative program as the agency's chief legislative advocate.

Accomplishments: December 2018

- Conducted ongoing legislative constituent relations regarding various Commission functions.
- Responded to questions from legislators regarding various Commission functions.
- Researched the potential impact and implementation of Amendment Four.
- Met with legislators to discuss the Commission's legislative priorities for 2019.
- Attended criminal justice committee meetings of the legislature.

Office of Communications

The Office of Communications is charged with overseeing the agency's communications and public information program.

Accomplishments: December 2018

- Published and distributed the Annual Report.
- Distributed the Employee Handbook and Reference Guide and posted to the internal website.
- Held first meeting of the employee mentor program.
- Held graphics meeting regarding projects for 2019.
- Created the 2019 Communications Outlook including goals, objectives, and strategies.
- Posted updates regarding Amendment 4 and the Board of Executive Clemency meeting to the external website.
- Drafted miscellaneous messages to staff.
- Distributed information to staff regarding office closures.
- Updated the Office of Communications Handbook and 2019 calendar of events.

Office of Executive Clemency

The Office of Executive Clemency (OEC) reports directly to the Governor and Cabinet who sit as the Clemency Board in the performance of their duties and responsibilities. This office is responsible for coordinating all clemency meetings, referring applications for investigation, and serves as the official custodian of all clemency records.

Accomplishments: December 2018

The main goal of the Office of Executive Clemency is to screen the daily submissions of applications in an expeditious manner in order to notify the applicants early on of their status in the first phase of a two-phase process. Detailed correspondence is provided to the applicants explaining the next steps in the process and advising of any additional information that is needed to move forward. Excellent customer service continues to be a priority.

December is always a time when we work hard to complete all business transactions for the current year and look forward to the next year and what it brings to the clemency world.

The December clemency meeting was postponed due to the passing of former President George H. W. Bush and Governor Scott's attendance in Washington, D.C. The dates for the upcoming clemency meetings will be set by the new administration once they are up and running after January 8. Those applicants who were listed on the December agenda will be included on the first 2019 meeting agenda.

All outstanding executive orders were filed with the Secretary of State; thus, bringing the actions of this Executive Clemency Board to a close for the calendar year. We are ready and prepared to assist the new administration with the ins and outs of the clemency process, any changes to the Rules of Executive Clemency, and the impact of the passage of Amendment 4 pertaining to voting rights.

Office of Clemency Investigations

The Office of Clemency Investigations is charged with investigating, reviewing, evaluating, and reporting to the Clemency Board in all types of clemency cases, including, but not limited to, the restoration of civil rights, restoration of alien status under Florida law, full pardons, firearm authority, commutations of sentence, remission of fines, and capital punishment cases.

Accomplishments: December 2018

- Prepared investigations for the upcoming Clemency Board Meeting and conducted quality assurance reviews of With and Without a Hearing investigations completed by field offices.
- Conducted investigations on Restoration of Civil Rights Without a Hearing cases.
- Conducted investigations on Requests for Review for Commutation of Sentence cases.
- Provided assistance and support related to eligibility determinations and clemency investigation procedures to Field Services staff.
- Published a revised Clemency Investigations Instructions Manual for conducting comprehensive investigative reports which are submitted to the Clemency Board.
- Researched the potential impact and implementation of Amendment Four.
- Assisted in responses to public records requests, legislative inquiries, and in other responses for clemency information/data requests.
- Provided customer service to clemency applicants.
