### FLORIDA PAROLE COMMISSION Monthly Accomplishments' Report July 2010

#### Featured Monthly Parole Case:

#### William Pauli, DC# 108289

On July 14, 2010, the Commission established a Presumptive Parole Release Date (PPRD) for parole eligible inmate William Pauli. Pauli was convicted in Marion County on July 13, 1987 for Sexual Battery on a Child under 12 years of Age and sentenced to a life sentence with a 25 year minimum mandatory. On the second count, Pauli was sentenced to a ten-year period of probation to run consecutive with the life sentence, but concurrent with his other convictions.

Pauli's additional convictions were: 2 counts Sexual Battery; 1 Count Sexual Battery; 1 count Indecent Assault on a Child; 3 counts Lewd and Lascivious Acts; 1 Count Sexual Activity with a Child; and 1 Count Indecent Assault on Child. Pauli was convicted of taking young boys to his residence and sexually assaulting them. Pauli has admitted his guilt and expresses no remorse for his actions.

The Commission set Pauli's PPRD at October 21, 2116 with a subsequent interview February 2015.

## JULY 2010 RCR STATUS

As of July 1, 2010, there were 81,757 pending RCR cases. There were 37,700 application cases and 44,057 EOS/TOS (eos/expiration of sentence; tos/termination of supervision) cases.

## COMMISSION ACCOMPLISHMENTS JULY 2010

- **Clemency Administration:** Continued reviewing all types of clemency cases; conducting eligibility reviews on RCR EOS/TOS cases, including quality assurance RCR reviews; the office has been in full mode of "office cleaning" and packing in anticipation of the agency move; and has sent additional closed clemency files to the State Storage Center.
- **Communications:** Director filmed an interview on the Status of RCR cases with WINK TV out of Ft. Myers; responded to public records requests.
- **Executive Clemency:** Developed a search mode allowing employees to locate applications received online that have not yet been entered into the MAC database;
- **Legislative Affairs:** Coordinated meeting with Dr. April Young of the Collins Center, Miami Office, and NAACP on clemency/RCR issues; agreed to continue a dialogue with the Center on how to enhance the Commission's efforts.
- **Legislative Affairs:** Met with House Public Safety Staff and answered questions during their July 14, 2010, visit to the Commission hearings.
- **Legislative Affairs & Clemency Administration:** Prepared response together with the Director of Clemency Administration for DOC's Re-entry Advisory Council workgroup meeting July 15, 2010 on RCR issues; attended Re-entry Council Workgroup's July 15 meeting for informational purposes.
- **Legislative Affairs:** Finalizing agency legislative proposals for submission to Governor's Office of Policy and Budget for consideration in the 2011 Legislative Session.
- **Legislative Affairs:** Working with the Commission's legal staff and the Florida House of Representative's staff in drafting legislation in response to Graham v. Florida. Conducting research and assessing an implementation process in the event the Legislature were to enact a juvenile parole statute.

- **Legislative Affairs:** Coordinated and prepared a response for Chairman Dunphy's signature for the Six-Month Follow-up Report on Auditor General Report No. 2010-010, delivered June 30 to the Joint Legislative Auditing Committee and Auditor General staff.
