Featured Case

Inmate Johnny Johnson #112876 was convicted of First Degree Murder, Robbery, and Kidnapping on August 16, 1988. At the time of offense, the inmate was **fifteen** years old and the co-defendant was **thirty-two** years of age. It was determined that the victim, a 55 year old female, was bound, gagged, wrapped up and removed from her residence along with several belongings and her vehicle. The co-defendant had dated one of the former tenants of the location where the victim's body was found. In addition, police determined the identification of the inmate and contacted his mother, who reported he was in custody in North Carolina. When contact was made, the inmate implicated the co-defendant and himself in the kidnapping, robbery and murder of the victim. The inmate gave police details and locations of the crimes and the location of the victim's care, used to flee to North Carolina. Inmate Johnson received a Life sentence with 25 years minimum mandatory and 12 years running concurrent for the additional charges. The Commission reviewed Inmate Johnson's parole. The Commission agreed and established a parole date for Inmate Johnson for September 24, 2013.

In other Commission news, the Florida Parole Commission kicked off the month of September by conducting our semi-annual business meeting allowing managers and leadership staff the opportunity to discuss our accomplishments and challenges over the last six months before the Commissioners. This meeting also gives us the ability to acknowledge our dedicated staff members who have served the state for many years, as well as the opportunity to introduce new agency employees. The following week we held our Florida State Employee Charitable Campaign (FSECC) Kick-Off event hosted by our very own Robby Holroyd, Kevin Reilly, Brittany Roberson, and able assistant Bonnie Davidson, who presented the new online FSECC program. They did an impressive job representing "Generation Me" while discussing various means to assist the community through charitable contributions. Many of our employees are planning to give to the campaign for the first time this year.

Continuing with our employee enrichment training series, Tony Sullivan and Jeffrey Rigdon conducted a website training class this month and discussed the "how to's" of creating a functional and productive website. Participants were guided through a step-by-step website builder program which can be used to easily create a website for small businesses or personal use.

In mid-September, I had the honor of attending the invitation-only **Sayfie Review Florida Leaders Summit. Led by Justin Sayfie, the S**ayfie Review is an online website that provides updates and commentary on Florida political news. I was delighted to join decision makers across the state for the first "offline" meeting to discuss impactful issues facing our state. My favorite part of the summit was the breakout sessions where we discussed Big Hairy Audacious Goals (BHAG's) in the areas of education, health, energy, water, transportation, and more. BHAG's are a way for leaders to conceptualize goals for the future of Florida and begin making strides to achieve them.

Finally, I had the privilege of visiting North West Florida Reception Center (Institution) where I spoke with inmates regarding Restorative Justice; accepting and recognizing the harm they have caused their victims, families, and communities, in an effort to reduce further victimization and criminal offending.

In closing, I would like to thank the clemency staff for providing findings on more than 70 cases for the Executive Clemency Board meeting on September 25. As always, your commitment to providing precise, accurate and detailed information made the process run smoothly.

COMMISSION SECTION ACCOMPLISHMENTS

<u>Operations</u> Shana Lasseter, Director

- <u>Business Meeting</u> The Commission's Semi-annual Business Meeting was held September 4, 2013, at the Commission's central office in Tallahassee. As always, the meeting was productive and informative. In addition to standard Commission business, the Commission was fortunate to have presentations provided by: Department of Corrections Deputy Assistant Secretary Michelle Pyle who reported on current affairs and initiatives at the Department, and Department of Corrections Director of Health Care Services, Dr. Olubenga Ogunsanwo, who discussed with the Commission the impact of health care privatization on Conditional Medical Release referrals.
- <u>Relocation of FPC's Region 3 Cocoa Field Office and Acquisition of Additional Offices in Region 4</u> With the assistance of the Department of Corrections, the FPC Region 3 field office in Cocoa was temporarily relocated to the Titusville Probation and Parole (P&P) Office during the week of September 9, 2013 due to the closing of Brevard C.I. The Department graciously offered the alternative office space, at no cost to the Commission, until the Commission can move to its permanent location in Melbourne in 2014. Additionally, the Commission officially requested additional office space at Department of Corrections P&P properties in Miami and Ft. Lauderdale. The Commission currently occupies nine offices at the Miami location and five in Ft. Lauderdale and was approved for two additional offices at each location to meet operational needs. Chair Pate formally thanked the Department for the cooperation and assistance the Commission has been provided over the years relating to the matter of the Commission co-locating with the Department. The teamwork is truly appreciated.
- <u>Objective Parole Guidelines Committee</u> During September, the committee provided Florida State University with initial score sheets for approximately 250 inmates paroled between 2004 and 2011. The FSU research team will enter the salient factor scores for each case into a database for comparison with recidivism data already on file. The committee meets consistently and has discusses topics including: RCF applications for juvenile offenses, calculating time in custody, rule revisions for matrix time ranges and assessment of aggravation and mitigation factors. Progress is expected to continue.

Richard Heagney, DC #068627 – In 1984, Richard Heagney was granted parole after serving approximately 4 years for Armed Burglary, in which he had received a LIFE sentence and Carrying a Concealed Firearm with a 5-year consecutive sentence. In July 2011, Heagney committed the offense of Sexual Battery on a Person less than 12 years of age, in Alachua County, Florida. The case involved him committing sexual battery upon a minor victim who was in his familial custody. He has been sentenced to LIFE imprisonment, in the Florida Department of Corrections, which resulted in his violation of parole. On September 25, 2013, the Commission revoked Heagney's parole and he remains in custody with two consecutive LIFE sentences. This case will be reviewed on or about in January 2014, to establish the inmate's new PPRD (Presumptive Parole Release Date) on his parole eligible sentence. Highlights / Accomplishments for the month of August 2013 for the Office of Clemency Investigations include:

- On September 3, 2013, Caroline Goodner, was hired as a Parole Examiner and will be conducting Restoration of Civil Rights eligibility investigations and quality assurance reviews.
- On September 5, 2013, this office provided a new resource, *Court Document Search*, for examiners conducting clemency investigations. This is a HTML resource for Examiners to use as an internal tool to provide an easy and convenient way to look up court documents and docket notes by county in the State of Florida and by state in the United States.
- On September 12, 2013, the Director of Clemency Investigations provided training to the Regional Administrators and Supervisors during a conference call to include procedures related to clemency investigations and the Rules of Executive Clemency.
- On September 14, 2013, Parole Examiner Jeff Rollins participated as the Race Director in this year's 32nd Annual 5K Run/Walk for Sickle Cell Anemia. Jeff has been the Race Director for the past five years and has volunteered countless hours for this event which raises awareness and funds for the Leon County Sickle Cell Foundation. The funds are used to assist clients of sickle cell anemia with the purchase of medication, transportation to doctor offices, sickle cell screenings, summer camp to Boggie Creek, and other related client services.

- On September 19, 2013, the clemency database workgroup comprised of members from the Office of Clemency Investigations, the Office of Executive Clemency, and Tony Sullivan, Department of Corrections OIT, met to discuss strategies and plans to work toward creating a clemency file management system which will include scanned documents. This is a long term goal as other IT issues are a priority at this time.
- On September 25, 2013, the Governor and Cabinet, sitting collectively as the Clemency Board, held its third quarterly Clemency Board Meeting at the Capitol. The Commission completed and submitted 79 in-depth clemency investigations for Full Pardons, Firearm Authority and Restoration of Civil Rights for consideration by the Board. The Coordinator of the Office of Executive Clemency presented the cases to the Board, and the Chair provided detailed information related to the Confidential Case Analyses and processes to the Board Members in response to their inquiries.
 - This office researched the specific reasons why applicants requested restoration of their civil rights. We reviewed the 56 Restoration of Civil Rights cases heard at the September 25, 2013 Clemency Board Meeting. Several applicants indicated multiple reasons in their statements to our examiners, and the following information is a brief summary of what our research revealed:
 - 1. 86% of the applicants specifically indicated that they were interested in regaining their right to vote, sit on a jury or hold public office.
 - 2. 25% of the applicants specifically indicated that they were interested in obtaining their civil rights to help them with employment, ranging from specific licenses or occupations to general job opportunities.
 - 3. 11% of the applicants did not provide any specific reason for requesting their civil rights.
 - 4. 34% of the applicants voted in an election without having their civil rights restored.
- The Director and staff assisted in the development of clemency information and prepared a semi-annual report for the agency's Business Meeting held on September 4, 2013.
- Staff in this office assisted in the development of clemency information for agency reports such as the Long Range Program Plan, Performance Measures, and Legislative Budget Requests.
- Conducted capital punishment clemency investigations and coordinated interviews for death row inmates.
- Conducted quality assurance reviews of all clemency investigations completed by regional field offices.
- Reviewed Restoration of Civil Rights cases for eligibility prior to sending them out to field offices for in-depth field investigations to be conducted, and conducted Request for Review investigations for commutation of sentence applications.

Executive Clemency Julia McCall, Clemency Coordinator

The Office of Executive Clemency conducted a quick audit of 1,078 Without a Hearing cases pending investigation for eligibility in the Office of Clemency Investigations. It was found that 20 of those cases were not eligible and thus closed. The applicants will be notified of their change in status. This audit enables the eligible cases to progress through the investigative system in a more timely manner.

We have also audited approximately 300 pending With a Hearing cases and found that all of those cases are eligible; thus, they will continue to move through the process. This office intends to continually monitor and audit pending cases in an attempt to produce results as efficiently as possible.

WEBPAGE STATISTICS

- The Florida Parole Commission has received 1,218,849 hits with 921,932 searches for Restoration of Civil Rights (RCR) grants.
- 98,581 names were located and 62,464 certificates have been printed.
- Currently there are 375,341 RCR certificates available for printing.

Legal Office Sarah Rumph, General Counsel

Some of the orders received this past month include:

- 1. <u>Cardenas v. FPC:</u> In this case, the control release challenged the 2006 revocation of his release credits, the forfeiture of gain time, and denial of credit for his time out on release. The Court denied all of his arguments.
- 2. <u>Moffett v. FPC:</u> In this parole case, the inmate was challenging that he did not have a meaningful parole hearing because he did not have an up-to-date psychological report. The court rejected this as a statutory requirement of the Commission. The Court stated that the statute requires the Commission review the entire record, including any reports that are already in there, and there was no indication that the Commission did otherwise. Some of the other arguments that the inmate attempted to raise were unclear challenges to his 1989 parole revocation. The Court dismissed these as barred, the delay having caused prejudice to the Commission.
- 3. <u>Whited v. FPC:</u> The parole-eligible inmate in this case was seeking an order for the Commission to place him in specific programming at Everglades Correctional Institution. The Court denied the inmate's request for relief and the inmate's specific challenges to the Commission's most recent action making no change to his PPRD.
- 4. <u>Brash v. FPC:</u> This case was unusual in that the inmate was seeking to have the Commission bar participation by the State Attorney in the Commission's public meetings as it related to his case. The Court rejected the inmate's arguments and found that there is no duty on the Commission to bar members of the public from their meetings and there is, in fact, a duty to the contrary since the meetings are public and open pursuant to the Sunshine Law.
