FLORIDA PAROLE COMMISSION Monthly Accomplishments Report April 2014

~CHAIR'S MESSAGE~ Tena M. Pate

The month of April has been a very productive month at the Parole Commission. We continued to refresh our image with the launch of our new and modern website this month. The updated site is designed to ease access to pertinent and timely information for our stakeholders, which include law enforcement and criminal justice partners, fellow state agencies, crime victims, victim advocates, inmate supporters, members of the general public and interested media. Our new website provides detailed information on every aspect of the Commission, and the new layout and features ensure that anyone visiting it can find what they are looking for in an effective and timely manner. In addition to viewing and downloading the Commission's voting schedule and corresponding agendas, individuals will be able to locate information on the various release types the Commission administers, Commission history and Commissioner bios, clemency information and applications, as well as an overview of the services available to victims of crime. One component of the new website is an emphasis on complete and factual information to correct the many misconceptions regarding our role as an agency and the status of parole in the state of Florida. Many prisoners believe that they can apply for parole; while others believe that there are not parole eligible inmates anymore. There are no mechanisms for inmates to "apply for parole eligibility" in the state of Florida. Inmates are determined eligible or ineligible for parole consideration based off of when their offense was committed. Further information regarding parole eligibility can be found in the Operations section of this report.

The 2014 Legislative Session is coming to a close and with that are some important changes to the Commission. The Legislature has approved additional funding for the processing of clemency cases, toll-free phone line operators for clemency services and a research analyst to support the Commission's initiatives. The House and the Senate also both voted favorably to rename the Florida Parole Commission to the Florida Commission on Offender Review (FCOR) to better reflect the duties and responsibilities of the agency. Once finalized, the budget and the name change bill will be sent to the Governor for his signature.

A statewide warrant sweep, to locate and serve warrants to parole and conditional release supervision absconders, was launched this month in partnership with the US Marshals Florida Regional Fugitive Task Force (FRFTF). To date, the sweep has resulted in dozens of arrests and disposed warrants. The Commission is grateful to the Marshals Service, the Florida Department of Law Enforcement, the Florida Department of Financial Services and the Florida Department of Health whose assistance was vital to the success of this initiative.

Earlier this month the Commission observed National Crime Victims' Rights Week with two events. To kick off the week, the Commission hosted a Victims' Rights Walk on Friday, April 4, where participants walked a designated one and a half mile route through our central office Southwood Complex and wore race bibs indicating a reason for supporting victims' rights. Posters positioned along the walking path informed participants of Commission's role in assisting Florida's crime victims. The Commission also welcomed Human Trafficking Advocate, Deborah Polston for an empowerment presentation on Thursday, April 10 in which Deborah shared vital information about this growing issue and important tips for spotting human trafficking in your community. The Commission's regional offices also attended and participated in events around the state to observe this important week.


The Parole Qualifications Committee, compiled of Florida criminal justice and law enforcement leaders appointed by the Governor and Cabinet, convened this month to begin the selection process of the Commissioner position which will open July 1st, when Commissioner Bernard Cohen's term expires.

In closing, I'd like to commend our staff members for their accomplishments throughout the month of April and give special accolades to Daphne Asbell who received the 2014 Charles Morris Victims Advocate of the Year Award from the Big Bend Victim Advocacy Coalition at their annual National Crime Victims' Rights Week luncheon.

COMMISSION SECTION ACCOMPLISHMENTS

Office of Legislative Affairs

Kevin Reilly, Director

Budget

The legislature approved additional funding for 10 additional full time employees (FTE). Nine of these FTE are within clemency to fund workload issues. The other additional FTE is for a research analyst to aid in special projects and enhance the work we do at the Commission. The legislature also agreed to provide OPS funding for clemency phone operators and provided \$125,000 for the Commission to manage clemency for capital proceedings.

In total, the Commission was awarded funds for 132 FTE and a total budget of \$9.57 million.

Name Change

The House and the Senate also both voted favorably to rename the Florida Parole Commission to the Florida Commission on Offender Review (FCOR) to better reflect the duties and responsibilities of the agency. Once finalized, the budget and the name change bill will be sent to the Governor for his signature.

Operations

SETTING THE RECORD STRAIGHT: There are many misconceptions regarding parole in the state of Florida. Many prisoners believe that they can apply for parole; while others believe that there are no parole eligible inmates left within the prison system. Parole eligibility as it exists today is described below.

There are no mechanisms for inmates to “apply for parole eligibility” in the state of Florida. Inmates are determined eligible or ineligible for parole consideration based on when their offense was committed.

An inmate is eligible for parole consideration if they committed:

- 1) a first degree murder, a felony murder, or the crime of making, possessing, throwing, projecting, placing, or discharging a destructive device (or the attempt of) prior to May 25, 1994
- 2) all other capital felonies prior to October 1, 1995
- 3) a continuing criminal enterprise (violation of s. 893.20, F.S.) prior to June 17, 1993
- 4) a murder of a law enforcement officer (and other specified officers) prior to January 1, 1990
- 5) a murder of a justice or judge prior to October 1, 1990
- 6) any felony prior to October 1, 1983, or those who elected to be sentenced “outside the guidelines” for felonies committed prior to July 1, 1984
- 7) any habitual felony offender sentence prior to October 1, 1988

There is no right to parole in Florida. Simple eligibility for parole consideration, does not, by any means, guarantee parole. Parole is a grace of the State.

Warrant Sweep Case: Ricky Bayles, DC#060035, was paroled in 1979 after serving 13 months of his 4-year sentence for Burglary. After four months on parole, Bayles absconded from supervision and remained a fugitive until the US Marshals located and apprehended him in West Virginia on April 3, 2014. At that time, West Virginia charged him with being a fugitive from justice based on the Commission’s warrant. In April 2014, Ricky Bayles waived extradition to

Florida and was returned to the custody of the Florida Department of Corrections where he is awaiting his revocation hearing.

Training

Revocations completed the annual Diversity Training. Supervisor Kim Dickey completed Dr. Tippy Amick’s 6-hour training: “From Supervisor to Leader” and Julia McCall’s training, “Why Employees Don’t Do What They Are Supposed To Do . . . And What To Do About It”. Supervisor also accompanied the US Marshals Service on a “warrant sweep” to capture Commission absconders/fugitives, during which she observed two fugitives being taken into custody.

Highlights / Accomplishments for the month of April 2014 for the Office of Clemency Investigations include:

- On April 10, 2014, the Director of Clemency Investigations provided training to the Regional Administrators and Supervisors during a conference call to include procedures related to clemency investigations and the Rules of Executive Clemency.
- On April 15, 2014, Carol Hargraves, was hired as a Parole Examiner and will be conducting Restoration of Civil Rights eligibility investigations.
- On April 23, 2014, our office completed a revised procedure directive related to the completion of clemency field investigations on capital cases.

Legal Office

Sarah Rumph, General Counsel

Soon it will be summer and things will be heating up. However, the Legal office is already on fire!

Some of the recent court orders are:

1. Garrison v. State of Florida: The former conditional releasee in this case argued that he was entitled to credit for the time he spent on conditional release. He contended that he was "in custody" while out on conditional release. The Court rejected this contention and found that the inmate failed to establish a legal entitlement to the credit.
2. Jones v. FPC: Mr. Jones had two cases pending. He has this case where the final order was issued and another case where he was challenging the decision of Executive Clemency to find him ineligible to apply for a commutation under the Rules. That case was dismissed in the Circuit Court and is now pending appeal. In the case at hand, he challenged the Commission action on his PPRD. The Commission modified the PPRD, extending it by 24 months due to disciplinary reports. The Court upheld this action.
3. Harris v. DOC & FPC: The former parolee in this case challenged the Commission's decision revoking his parole in 1989. He claimed that the Commission lost jurisdiction over him because it started revocation proceedings after the original parole term date. The court found the claims to be without merit since the warrant was issued prior to the expiration of the term. It also dismissed them for procedural reasons since the inmate had already challenged the revocation previously in court and since he is bringing the challenge almost 25 years after the revocation.

This month, the PQC process started and is kicking in to high gear. The goal is to get three names to the Governor and Cabinet for consideration at the June 17th Cabinet meeting. We hope to conclude the PQC activities by the end of next month.
